Privacy Statement of Football Heroes

APPLICABILITY AND SCOPE OF THIS PRIVACY STATEMENT

Football Heroes attaches great importance to the protection of your personal data. With this Privacy Statement we want to provide clear and transparent information about how we handle your personal data.

We do everything we can to safeguard your privacy and therefore handle personal data with care. Football Heroes complies in all cases with the applicable laws and regulations, including the General Data Protection Regulation. This entails the following:

- We process your personal data in accordance with the purpose for which they have been provided. These purposes and type of personal data are described in this Privacy Statement;
- The processing of your personal data is limited to the data which are at least necessary for the purposes for which they are processed;
- We ask for your explicit consent if we need it for the processing of your personal data;
- We have taken appropriate technical and organisational measures to ensure the security of your personal data;
- We do not pass on personal data to other parties, unless this is necessary for carrying out the purposes for which they have been provided;
- We are aware of your rights regarding your personal data, and we want to inform you about them and respect them.

This Privacy Statement applies to all personal data that Football Heroes processes of its members, sponsors, donors, participants or other interested parties. When you are a member of Football Heroes, register for one of our clinics, events, our services or otherwise contact us, the personal data provided and used by you will be recorded and processed.

DATA CONTROLLER

Football Heroes is a general partnership with full legal capacity that is engaged in the practice of football, i.e. providing football training, clinics and acting as a player mediator.

Football Heroes, with registered office in (1821 BV) Alkmaar at Einthovenstraat 111 (Chamber of Commerce number 75324431), determines the purposes and means of processing personal data and is therefore to be regarded as the data controller.

PROCESSING OF PERSONAL DATA OF MEMBERS

Personal data of members are processed by Football Heroes for the following purpose(s):

- Maintaining contact about the membership and the possible termination thereof;
- Collecting membership fees;
- Sending invitations and information about services and activities of Football Heroes.

The ground for the processing of these personal data:

- The data subject has given their consent for the processing of their personal data for these purposes. This may or may not have been done when filling in the membership administration form, whether or not via the website.

For the above purpose(s), Football Heroes may request the following personal data from you:

- First name;
- Middle name;
- Surname;
- Date of birth;
- Place of birth;
- Nationality;
- Address details;
- Telephone number;
- Email address;
- Clothing sizes;
- Bank account number.

PROCESSING OF PERSONAL DATA OF PARTICIPANTS

Personal data of participants are processed by Football Heroes for the following purpose(s):

- Maintaining contact about the event in which the participant participates;
- Sending invitations and information about events, services and activities of Football Heroes.

The ground for the processing of these personal data:

- The data subject has given their consent for the processing of their personal data for these purposes. This may have been when filling in the participation form for the event in question, whether or not via the website. In doing so, the data subject gives their consent for images and photographs to be made. These may be used by Football Heroes on its website and social media channels.

For the above purpose(s), Football Heroes may request the following personal data from you:

- First name;
- Middle name;
- Surname;
- Date of birth;
- Place of birth;
- Nationality;
- Address details;
- Telephone number;
- Email address;
- Clothing sizes;
- Bank account number.

DATA PROVISION TO THIRD PARTIES

Without your express consent, Football Heroes will not provide any personal data to third parties, subject to the following:

- Football Heroes may be required under applicable laws and regulations to provide certain personal data, for example in the context of an investigation. In such a case, Football Heroes will only provide the personal data if it is clear that there is a legal obligation to do so.

If we engage a data processor, we will make the necessary arrangements with this party to ensure the security of your personal data. The agreements will be laid down in a processing agreement.

WITHIN THE EU

We do not provide personal data of participants in the football academy and clinics to parties based outside the EU. The personal data that Football Heroes uses for its player mediators branch may be shared with parties based within or outside the EU. This is for the benefit of contractual negotiations for the player.

MINORS

We only process personal data of minors (persons under 16 years of age) if written consent has been given by the parent, guardian or legal representative. By agreeing to this written consent, Football Heroes is entitled to use visual material of the minor for its website and social media channels.

RETENTION PERIODS

Football Heroes retains personal data for as long as necessary for the purposes for which they were collected, or for as long as there is a statutory retention period.

In general, the following retention period for personal data collected from members applies:

- The data are kept for the period of your membership up to a maximum of one year after the end of the membership. Thereafter, the data will be destroyed.

In general, the following retention period for personal data collected from players where Football Heroes acts as their mediator applies:

- The data are kept for the duration of the sponsorship and up to 1 year after termination. Thereafter, the data will be destroyed.

In general, the following retention period for personal data collected from participants applies:

- The data are kept for the period of participation in the event in question and up to 1 year after the event has ended.

FOOTBALL HEROES

If the data are no longer necessary for the purposes for which they were collected and/or there is no longer a legal retention period, the data will be destroyed.

SECURITY

Football Heroes takes care of appropriate technical and organisational measures to protect your personal data against unlawful processing.

RIGHTS CONCERNING YOUR PERSONAL DATA

You have the right to access, rectify or erase the personal data that Football Heroes has received from you. You may also object to the processing of all or part of your personal data by Football Heroes or one of our data processors. You also have the right to have the data provided by you transferred by Football Heroes to yourself or on your instructions directly to another party. Football Heroes may ask you to identify yourself before we can comply with the aforementioned requests.

If Football Heroes processes your personal data on the basis of your consent to do so, you have the right to revoke your consent at any time. This can be done by contacting Football Heroes using the contact details below.

COOKIES

When using the Football Heroes website, Football Heroes may collect information about your use of the website, for example by means of cookies. More information about cookies can be found in the Cookies Statement as included on the website www.footballheroes.nl.
